DIRECTIONS FOR USE:

Vegetable and Row Crops: Foliar Application: Use 1 to 2 pints per acre in a minimum of 25 gal. of water. Apply at 2 to 3-week intervals. Repeat applications as needed.

Transplant Application: Soak seedling and transplant roots before planting at a rate of 1 to 2 pints per 25 gal. of water.

Citrus and Tropical Fruits: Foliar Application: Use 1 to 2 pints per acre in a minimum of 50 gal. of water. Begin at pre-bloom, repeat applications as needed every 2 to 3 weeks.

Greenhouse and Nursery: Use 2 to 3 pints per 100 gallons of water and apply as a foliar spray or soil drench. Can be applied through injector systems.

Lawns, Turf, Golf Courses:

Apply 0.5 to 1.5 ounces per 1,000 sq. ft. with enough water to ensure thorough coverage. Apply every 3 to 4 weeks or as needed.

Applied as a Zone Management Oriented (ZMO) product. Avoid mixing with acidic chemicals or calcium rich fertilizers as this may cause precipitation.

CAUTIONS: Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. Keep away from children. Do not contaminate water supplies.

ANTIDOTES: Skin or eye contact: Flush thoroughly with water and see a physician. Internal: Induce vomiting if conscious and get medical attention at once.
